

Town of Clinton Annual Meeting April 17, 2021

Chairman John LaDue called the meeting to order at 10 am at the town hall with the pledge of allegiance. Veterans in attendance were acknowledged for their service: Mr. LaDue and Wally Hemmersbach.

Scot Sanders made a motion to approve the previous year's minutes, 2nd by John Adams; all ayes, motion carried.

Mr. LaDue noted the purpose of the meeting was to advise the new board. Wayne Leis made a motion to vote on any matters with a show of hands, 2nd by Mr. Adams; all ayes, motion carried.

Wayne Leis questioned the purchase of the loader. Mr. LaDue noted that the purchase followed procedure. Mr. Leis made a motion to require special meetings for equipment purchases over \$40,000, 2nd by Dale Von Ruden: 7 in favor, 7 against. Mr. Leis made a motion to clarify purchases; motion passed by one vote.

Mr. LaDue made a motion to require special meetings for borrowing of funds in excess of \$40,000, 2nd by Pandora Flores; 9 in favor, 6 against. Budget hearings allow for electors to approve or disapprove the town budget and levy.

Wayne Leis made a motion, 2nd by Mr. Von Ruden, to investigate advertising meetings; 14 in favor. Mr. LaDue observed that attendance was not impacted by publishing notices.

Fred Brandt expressed an interest in public comment at board meetings. He made such a motion, 2nd by Mr. Leis; 13 in favor.

Since the state requires that the annual meeting is held within a particular timeframe, Mr. Adams made a motion to hold next year's meeting at 10 am at the town hall on April 23, 2022, 2nd by David Clark; nearly unanimous, motion passed.

At 10:40 am, Mr. Sanders made a motion to adjourn, 2nd by Mr. Hemmersbach; nearly unanimous, motion passed.
