### **Shop Cement Replacement:**

- Should also put a 2" mat of blacktop around the new cement in the next year.

## **2025 Road Projects:**

- Knapp Valley Road by David Detweiler's needs another tube, by the sugar shack, a spring runs constantly and needs ditching with culvert addition to get the water to run properly.
- Lots of tree damage recently. Goplin Road has a couple of dead trees which may be in the right of way, not sure. Need to measure and see. If not will talk to landowner.
- Sink holes showing up- watch out for them and report when seen so they can be fixed.
