- M/S/P: Chapiewsky/Giles moved to approve the 7.16.26 transfer from Savings to Checking of \$4,165.07 and the transfer of \$54,700.00 from Tax Savings to Checking. (3 ayes)

- M/S/P: Giles/Chapiewsky moved to Amend budget as follows: (3 ayes)
